All of the shares reported as disposed of in this Form 4 were relinquished by the reporting person and cancelled by the issuer in exchange for the issuer's agreement to pay federal and state tax withholding obligations of the reporting person resulting from the vesting of restricted stock units.
- The price reported in column 4 is equivalent to the fair market value based on the closing market price as of March 24, 2023.
- Each restricted stock unit represents a contingent right to receive one share of common stock at vesting.
- The restricted stock units vest and become exercisable in 25% installments on each anniversary date of the grant, March 25, 2022, subject to continued service through each applicable vesting date. The reporting person was granted 37,028 restricted stock units, of which 9,257 vested on March 25, 2023; 9,257 will vest on March 25, 2024; 9,257 will vest on March 25, 2025 and 9,257 will vest on March 25, 2026.
