- Options vest and become exercisable in 25% installments on each anniversary date of the grant, March 28, 2018, subject to continued service through each applicable vesting date. The reporting person was granted 3,198 options, of which 799 of the options vest on March 28, 2019; 800 of the options vest on March 28, 2020; 799 of the options vest on March 28, 2021 and 800 of the options vest on March 28, 2022.
- Each restricted stock unit represents a contingent right to receive one share of common stock at settlement.
- The restricted stock units vest and become exercisable in 25% installments on each anniversary date of the grant, March 28, 2018, subject to continued service through each applicable vesting date. The reporting person was granted 1,019 restricted stock units on March 28, 2018, of which 254 of the restricted stock units vest on March 28, 2019; 255 of the restricted stock units vest on March 28, 2020; 255 of the restricted stock units vest on March 28, 2021 and 255 of the restricted stock units vest on March 28, 2022.
