The reporting person was granted 35,866 options, of which 8,966 of the options vest on March 22, 2018; 8,967 of the options vest on March 22, 2019; 8,966 of the options vest on March 22, 2020 and 8,967 of the options vest on March 22, 2021.
- Each restricted stock unit represents a contingent right to receive one share of common stock at settlement.
- The restricted stock units vest and become exercisable in 25% installments on each anniversary date of the grant, March 22, 2017, subject to continued service through each applicable vesting date. The reporting person was granted 11,762 restricted stock units on March 22, 2017, of which 2,940 of the restricted stock units vest on March 22, 2018; 2,941 of the restricted stock units vest on March 22, 2019; 2,940 of the restricted stock units vest on March 22, 2020 and 2,941 of the restricted stock units vest on March 22, 2021.
