Explanation of Responses:

All of the shares reported as disposed of in this Form 4 were relinquished by the reporting person and cancelled by the issuer in exchange for the issuer's agreement to pay federal and state tax withholding obligations of the reporting person resulting from the vesting of restricted stock units.
- The price reported in column 4 is equivalent to the fair market value based on the closing market price as of March 24, 2022.
- Each restricted stock award is the economic equivalent of one share of Ollie's Bargain Outlet Holdings, Inc. common stock.
- The reporting person was granted 5,965 restricted stock units on March 24, 2020, of which 1,491 of the restricted stock units vested on March 24, 2022. The common stock into which such vested restricted stock units converted on March 24, 2022 is reported in Table I on this Form 4. The remaining unvested stock units will continue to vest with 1,491 of the restricted stock units vesting on March 24, 2023 and 1,491 restricted units on March 24, 2024.
